The Parties to this appeal, which is currently scheduled to be argued on November 5, 2019, jointly write this letter to inform the Court that ON Semiconductor Corporation (“ON Semiconductor”)—corporate parent of Defendants-Appellants Fairchild Semiconductor International, Inc. and Fairchild Semiconductor Corporation—has entered into a settlement agreement with Plaintiff-Cross-Appellant Power Integrations, Inc.
