Zydus respectfully submits that the panel's decision was confusing as to its application of the law of both literal infringement and infringement under the doctrine of equivalents. Zydus further suggests that the panel's decision will create uncertainty, especially with respect to the doctrine of equivalents, as well as the extent to which a court may apply its own technical expert opinion against an accused infringer, where that court's expert opinion is contrary to that of the patentee's proffered expert opinion, and indeed contrary to any other technical expert's opinion in a case consolidated for trial.
